OPENING PROCEDURES

PUBLIC COMMENTS

Open public comments: Steve Benson, just monitoring the meeting today.
 He is a test proctor at Santa Paula adult school and just wanted to see how this financial time is affecting other members.

DISCUSSION

- VCAEC Letter to Legislators. Discussion of next steps re: VCAEC letter to legislators regarding the timely distribution of CAEP funds. All signatures from member representatives have been received and added to the draft letter. Kathy Walker will send the finished letter to legislators on behalf of Mike Sanders and consortium members. It was also agreed that the letter should be disseminated to consortium leads statewide. Kathy will obtain contact information and disseminate accordingly.
- CAEP Funding. Discussion of the impact of the reduction in CAEP funding
 resulting from COVID:19 pandemic. Members noted the impact will vary
 by agency, and that due to health concerns, it is anticipated that
 custodial and maintenance costs will increase significantly. Likewise,
 agencies may need to purchase additional supplies such as plexiglass
 partitions, thermometers, and clear face-shields for instructors.

Member allocations were also discussed. In keeping with guidance from the CAEP office, it was agreed that member allocations would be reduced by 12.105 percent equally.

Reallocating carryover and consortium-level funds were discussed as a

way of mitigating shortfalls. Estimated amounts included funds earmarked for professional development (\sim \$156k), job development (\sim \$128k), and remaining carryover funds from Santa Paula held by the consortium (\sim \$149k). Additionally, Greg shared that WestEd would release funds allocated for the 2020:2021 contract (\sim \$142k).

Members resolved to discuss options for reallocation of funds once the Governor's budget is finalized.
